**ORS 323.706 Requirements for person's delivery sale purchase orders:**

**OREGON LAW PROHIBITS SHIPPING TO INDIVIDUALS UNDER 18 AND REQUIRES THE PAYMENT OF ALL APPLICABLE TAXES.**

**Tobacco consumer shall comply by the following:**

- a.) Age verification (at least the legal minimum purchase age), with photocopy or other image of a valid, government – issued identification stating the age or date of birth.**
- b.) Acknowledgement of “Notice to prospective consumer” re: ORS 323.715 Statement that tobacco sales to persons under the legal minimum purchase age are illegal. Proof of age. Sales of tobacco products are subject to tax under ORS 323.500 to 323.645 and an explanation of how the applicable tax has been paid or is to be paid.**
- c.) Acknowledgement of tobacco tax responsibility when receiving tobacco product outside the state of Oregon. Tobacco product shipped within the state of Oregon will include all the required state and federal tobacco tax by 82nd Ave. Tobacco & Pipe Ltd., and or their suppliers. Tobacco product shipped outside the state of Oregon will not include the out of state tobacco tax. The appropriate state tobacco tax requirements of “tax payment” will be the purchasers’ responsibility.**
- d.) Signing, agreeing to and returning of the attached age verification and statement form.**
